(i) Property /Municipal Tax :

- b. If there is any separate Property Tax bill directly on the premises licensed to the Licensee by any Statutory Body in future, the same shall be liable to be paid in its entirety by Licensee alone and shall continue to pay during the currency of this License Agreement till its expiry and / or till the licensee vacates and handover the vacant possession of the licensed premises back to the Licensor.

(ii) Sharing of energy charges on the basis of energy units consumed by CCI and Successful Bidder :

The unit consumptions are determined through separate meter readings allotted for the ground floor area by Building Maintenance Authority and the rate for energy charges shall be applicable as under: -

- a. The energy units consumed by licensee shall be charged as claimed by Building Maintenance Authority.
- b. In case of additional supply if required, the Licensee will have to obtain prior permission from Licensor and additional deposits / expenses (non-refundable), as will be charged by the Building Maintenance Authority, will have to be borne by the Licensee.

(iii) Sharing of other expenses i.e. operation & maintenance charges on Fire-Fighting, Lifts, AC maintenance and DG Sets, etc.

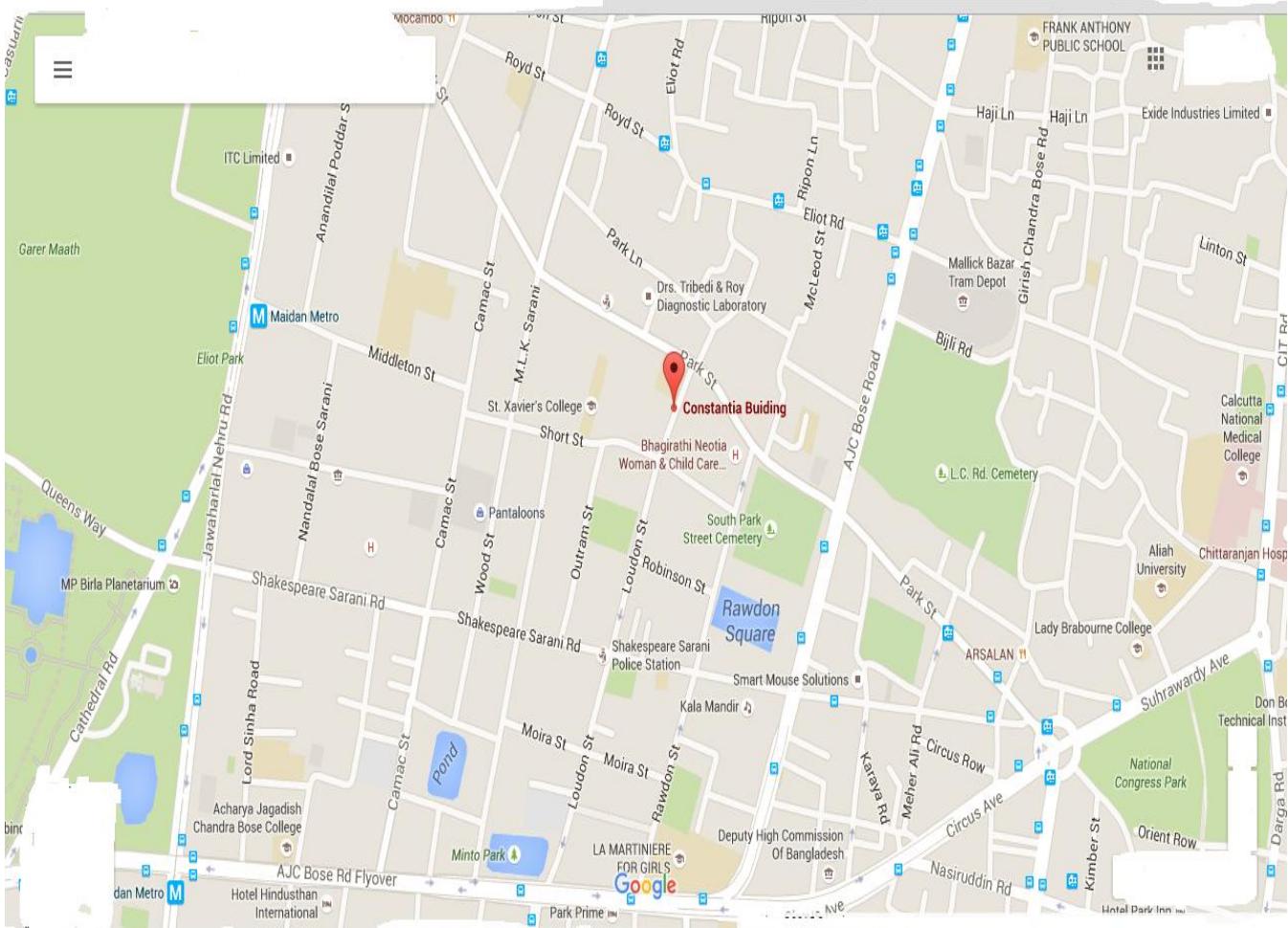

1. Interested parties may visit the site on any working day between 11.00 a.m. to 5.00 p.m.
2. The Bidder should quote its monthly License fee for total area offered only and not for the part area. The quotes received for part area will not be considered.
3. **The offer shall remain valid for a period of 90 days from the last date of opening of tenders.**
4. The above property i.e Ground floor, admeasuring area of 2601 sq.ft situated at **"Constantia", 3rd floor, 11, Dr. U.N. Brahmachari Street, Kolkata – 700 017** is offered under Leave and license agreement initially for five (5) terms of Eleven (11) months each with option to renew on expiry of said License period for further five terms of 11 months each on mutual agreed terms otherwise the tenant shall have to vacate the premises on expiry of 55 months.
5. The monthly License fee to be fixed on the basis of this tender shall be revised upwards by 5% of License fee after expiry of each terms of 11 (eleven) months.

6. The Earnest Money Deposit of Rs.50,000.00 (Rupees fifty thousand only) of the successful bidder will be adjusted against the interest free Deposit equal to Three Months license fee while the same will be re-funded to the unsuccessful bidders. Successful Bidder will have to deposit at the time of execution of leave and license agreement and keep deposited with the corporation during the period of this agreement and renewal thereof an interest free deposit equal to three months license fee (monthly license fee), which is refundable on the expiry of the period of the licence or earlier determination or termination thereof as hereinafter provided on handing over vacant possession of the premises to the Licensor after adjusting outstanding dues, if any.
9. In lieu of assigning rights of exclusive use of the above property, The Corporation shall charge License Fee on monthly basis payable in advance i.e. by 10th of every month.
10. Successful Bidder will not be permitted for erection or to make any structural alterations or additions whatsoever to the said premises licensed to or any part thereof without the specific prior written permission of the corporation except modification of toilets, change of flooring and false ceiling, internal wooden partitions, cabins, shelving racks, electrical equipment and other interior works of temporary nature at their cost.
11. Successful Bidder shall have to conform with the administrative discipline set up by the corporation as well as Building Maintenance Authority for the floor as may be mutually agreed.
12. Successful Bidder shall not assign, sublet or transfer the rights of the licensee under the leave and license agreement in any manner to any person(s)/party (ies).
13. The proposed office premises for leave & license shall have False ceiling A.C duct over false ceiling and tiles fitting flooring. Successful Bidder shall have to make their own arrangement for interior works, if desired but will submit the Layout Plan for Interiors to the corporation, to enable the corporation to assess whether the successful Bidder is making any structural alterations to the said premises.
14. The total expenses related to stamp Duty and registration Fee of Agreement will be shared 50: 50 between the corporation and successful Bidder
15. The above office premise has been considered for letting out on leave and license agreement exclusively for office purpose only with General office Working time only i.e Monday to Saturday and the area should not be used for any other purposes viz. restaurant / shops / entertainment. etc.
16. The tenders received within the specified time shall be opened on the same day at the given time in the presence of Bidders who may wish to remain present. Tenders received late will not be accepted at any circumstances.
