The MSE certificate should be relevant to nature of work of tender. However, security deposit of Rs 50,000/- for each godown location separately has to be deposit in branch office by successful bidders before signing of agreement.

## TENDER FOR JOB WORK AT GODOWNS for Cotton Season 2022-23

### Terms & Conditions:

1. The last date of submission of the tender to this Office is 11:30 AM on 30.08.2022
  - a) The date of opening Technical bid-I of the tender is on 30.08.2022 at 12:00 PM
  - b) The Financial bid-II of the tenders who qualified for the technical bid will be opened on 30.08.2022 after opening technical bid.
2. Tenders should be submitted in the prescribed format in form of "Bid-I and Bid-II". The Job contractors should submit these two bids in separate sealed envelopes duly marked as "Bid-I(Technical) or Bid-II (Financial)" and then place the two sealed envelopes into one envelop duly sealed and super scribed as "Job work contract in godowns for cotton season 2022-23".
  - **Bid-I (Technical)** should be submitted along with EMD, tender fee, signed terms & conditions & all other documents desired as per tender.
  - **Bid -II (Financial)** should contain only financial bid. For Each godown location applied, separate Bid-II (Financial) is to be enclosed.
3. All columns in the tender form should be filled in clearly and legibly. Tender form found as incomplete in any respect, is liable to be rejected.
4. The Contractor having legal dispute continuing /pending with the Cotton Corporation of India Ltd as well due payable by the Contractor is not eligible to participate.
5. Contractor has to pay Rs.50,000 towards E.M.D. for each godown location mentioned in Tender Terms & Conditions clause no.30 along with the tender by way of DD/pay order of any nationalized/scheduled bank drawn in favour of The Cotton Corporation of India Ltd, Payable at Mahabubnagar. Electronic Fund Transfer/Digital mode of payment should be made such as BHIM, UPI, (UPI/BHIM-UPI QR Code) and RTGS/NEFT. Electronic Fund transfer will be valid subject to confirmation of realization. MSE firms are exempted from EMD on production of valid MSE certificate which should be relevant to nature of work of tender; however, security deposit of Rs 50,000/- for each godown location separately has to be deposit in branch office by successful bidders before signing of agreement. No interest will be paid on EMD/Security Deposit. EMD/Security Deposit will be refunded after satisfactory completion of work at the end of the season.
6. The Contractor shall abide by all terms & conditions prescribed by the Cotton Corporation of India Ltd. The Contractor also agree to abide by all Rules, Acts, Provisions for employing labourers to do the work related to FP bales as per Minimum wages Act, Provision of Provident Fund Act, Payment of wages Act, provisions relating to employing children & women, workmen compensation Act, Bonus Act, Shops and Establishment Act, Factories Act and all other rules and acts not specified hereunto. Violation of any such rules will invoke penal action on the contractor as per laws.
7. The applicant must have P.F Code No, PAN No and GST No. The certified copies of all the Certificates must be attached with Technical Bid.
8. The Contractor has to submit the certified copy of the P.F. Challan to CCI every Month, establishing payment of P.F deposited with P.F Department. In case of nonpayment / less payment of P.F, the contractor will be wholly responsible for all liabilities due to P.F Dept.
9. The rates once finalized will be inclusive of any probable increase that may be made by the Government in Minimum wages Act and contractor shall not demand any proportionate increase or revision in the finalized rates till the period under the agreement is completed.
10. Other things being equal and meeting the requirements of the Corporation, preference will be given

to tenderer who has quoted the lowest Job work rates. However, rates shall not be the sole criteria for appointment of contractors and other factors like quality of work by the contractor and having clean track record and no pending disputes with CCI and past performance etc., shall also be considered.

11. Corporation will consider appointing such contractors those who have required infrastructure.
12. The bills accompanied with all supporting documents; P.F. Challan etc. duly acknowledged by Centre Incharge/Godown incharge should be submitted to B.O.
13. 10% deduction will be made from bills submitted by the Job work contractor as security deposit which will be released at the end of the season on satisfactory completion of work by Job work contractor. However, no interest will be paid on such security deposit. Satisfactory completion certificate to be obtained from concerned Godown In-charge.
14. The payment will be made through e-payment (RTGS/NEFT etc.)
15. The rates once finalized shall be valid till 30.09.2023 and may be extended by the corporation for a further period if necessary.
16. The Job work contractor shall compensate the corporation in the event of any delay in work on account of insufficient number of labourers supplied by the contractor. In this regard, the decision of the Godown-in-charge shall be final & binding on the contractor.
17. In case of any dispute on any term's interpretation etc. the decision of the Branch Manager, CCI Ltd., Mahabubnagar shall be final and binding on both the parties.
18. The rates quoted by the party should inclusive of all but excluding GST.
19. All statutory deductions such as Income Tax, GST TDS, Surcharges etc., will be deducted from the bills at the prevailing rates as per Income Tax Act 1961, GST Provision.
20. The contractor shall ensure proper safety of the goods/stock of Corporation. The contractor shall undertake to compensate the corporation for any loss arising out of willful act of the contractor / labours or cause any kind of damage to the corporation's property. Also, contractor will be penalized for any kind of mishandling of Corporation's stock resulting in damage to quality/packing as determined by Corporation.
21. The contractor shall obtain worker's Insurance policy with the Insurance Company and pay the premium and shall not claim any amount from the Corporation. The contractor shall pay compensation if any in case of accidents and Corporation will not be responsible.
22. In case of any legal suit filed against the Corporation by any workmen, the Corporation is authorized to recover the loss/expenses if any from the contractor.
23. Whenever the labour department demands to furnish the records or documents pertaining to labourers, the contractor shall produce the same to their best satisfaction.
24. The Job Work Contractor will raise bill and forward it through concerned Godown Incharge to Branch Office on monthly basis latest by 5th of every month. Bill for the month of March 2023 is to be submitted by 10th April 2023. Bill of financial year 2022-23 received after 10th April 2023, may not be considered by Branch Office for payment.
25. The Loss sustained by the Corporation due to the negligence / non supply of labour by the concerned contractor, Corporation shall be liable to carry the work through other contractor and loss if any suffered by the Corporation shall be recovered from the bills / EMD's / Security Deposits of original contractor.

26. The job Contractor shall ensure to provide sweeper as and when required by CCI for cleanliness of godown. The job contractor shall ensure that godown is cleaned after loading/sample cutting/unloading etc. work.
27. The job work Contractor shall ensure to provide trolley for stacking & de-stacking of bales at CWC/SWC/APMC Godown.
28. The job Contractor shall charge the same rate as finalized in tender for loading of bales from cotton buyers to whom the cotton bales were sold by CCI at the time of loading of bales. The Job Contractor has no right to enhance the said rates under any circumstances.
29. Eligibility criteria to qualify :
- The tenderer must enclose demand draft of requisite amount of EMD and tenderfees.
  - The tenderer must have Provident fund Number allotted by P.F. department.
  - The tenderer must have PAN allotted by Income tax department.

The dispute shall be governed by Arbitration and conciliation Act 1996.
35. Mere submission of the tender form does not entitle any Job contractor to be engaged by the Corporation. The corporation reserves the rights to accept/ partly accept/ reject any/ all tenders. The Corporation is not bound to allocate minimum work to the tenderer.

I/We, the Job work contractor agree to the deduction of 10% from every bill submitted by us towards security deposit which will be released at the end of the season on completion of work, satisfactorily. Completion certificate to be obtained from concerned Centre in-charge/Godown Incharge. However, no interest will be paid on such security deposit.
4. I/We, the Job work contractor also agree to abide by all terms & conditions mentioned in the tender dtd. .... by the Cotton Corporation of India Ltd, Mahabubnagar. I/We, the Job contractor also agree to abide by all Rules, Acts, Provisions including minimum Wages Act, Payment of Wages Act, Provisions relating to employing children and women, workmen compensation Act, Provident Fund Act, Bonus Act, Shops and Establishment Act, Factories Act and all other rules and acts not specified hereunto. for employing labourers to do the work of handling of bales and Misc. Items such as Tarpaulins, Lint boundaries, Grey cloth and Jute twin etc.,
5. I/ We, the Job work contractor agree to submit the certified copy of the P.F. Challan to CCI every Month, establishing the payment of P.F. deposited with P.F Department. In case of non-payment / less payment of P.F., I / We, the Job work contractor will be wholly responsible for all liabilities due to P.F Department.
6. I / We, the Job work contractor also give an undertaking that the Cotton Corporation of India Ltd., will not be responsible for non-payment of any dues directly to the labourers and we shall be held responsible for making all legal and lawful payments to be made to the labourer and the rate mentioned above covers all such payments.
7. The rate quoted by Job work contractor for kapas, bales and Misc. items such as tarpaulins, lint boundaries, Grey cloth and jute twin etc., handling work entrusted by the Corporation is valid for a period from date of agreement to 30.09.2023. In case of necessity, The Corporation may extend the contract period by 3 months with same rate and Terms and Conditions which is agreed by Job work contractor.

8. I / We, the Job work contractor agree to sign all the legal documents, contracts and undertakings as prescribed by the Corporation in support of contracts to be entered into with us for the work, for which the quotations are submitted. All expenses / fees to be paid to the Labour department/labour court for registration etc. will be borne by Job work contractor.
9. I / We, the Job work contractor undertake to compensate the Corporation, in case of any delay in handling work on account of insufficient number of labourers supplied by me to do the Job work and quality of work. In this regard the decision of Godown-in-charge, CCI is final & binding on me/ us.
10. I / We, the Job work contractor agree that the Corporation is no way concerned in case of any increase in labour wages or any such increase due to amendment of any Government acts and I/We, shall not demand any proportionate increase or revision in the agreed rates till the completion of contract period, mentioned in **clause no. 2** of this agreement.
11. In case of dispute, on any terms interpretation etc. the decision of the Branch head, CCI, Mahabubnagar shall be final and binding on both the parties.
12. The rates quoted by the party in clause no.2 of this agreement are inclusive of all taxes excluding GST.
13. All statutory deductions such as Income Tax, GST TDS, Surcharges etc., will be deducted from the bills at the prevailing rates as per Income Tax Act 1961, GST Provision.
14. I/We, the Job work contractor will ensure proper safety of the goods/stock of Corporation. The Job work contractor shall compensate the Corporation of any loss arising out of willful act of the Job work contractor/labours or cause any kind of damage to the Corporation's property. Also job work contractor will be penalized for any kind of mishandling of Corporation's stock resulting in damage to quality/packing as determined by the Corporation.
15. I/We the Job work contractor agree to take worker's insurance policy with the Insurance Company by paying premium and we shall not claim any amount on account of this from the Corporation. Corporation is in no way responsible for any accident, during the contract period and I / We, the Job work contractor will also not claim any compensation for the same from the Corporation.
16. I / We, the Job work contractor undertake to indemnify the Corporation that in case of any legal suit, filed against the Corporation by any workmen, the Corporation is authorized to recover the same from the Job work contractor.
17. I / We, the Job work contractor undertake to compensate Corporation any fine / penalty if any imposed by the State Government authorities for non-compliance of provisions of labour Laws Act, factory, shops and establishment act, provident fund Act, Minimum wages Act, Work men Compensation Act, Payment of Bonus Act, provisions relating to employing children and women etc. I/We, the Job work contractor will be responsible for the same. Violation of any such rules will invoke penal action on the contractor as per laws.
18. In case of the loss sustained by the Corporation due to the negligence/non supply of labour by the concerned job work contractor, Corporation shall be liable to carry the work through other job work contractor and loss if any suffered by the corporation shall be recovered from the bills/EMD/Security deposit of the original job work contractor.
19. The job Contractor shall ensure to provide sweeper as and when required by CCI for cleanliness of godown. The Job Contractor shall ensure that Godown is cleaned after loading/sample cutting/unloading etc work.
20. The job Contractor shall ensure to provide Trolley for stacking & de-stacking of bales at CWC/SWC/APMC Godowns.

21. Whenever labour department or any other Govt. Agencies demands to furnish the records or documents pertaining to labourers. I/We, the Job work contractor undertake such responsibility to produce the same to the best satisfaction.
22. The Job Work Contractor will raise bill and forward it through concerned Godown Incharge to Branch Office on monthly basis. Bill for the month of March 2023 is to be submitted latest by 10th April 2023 by the Job work contractor. Bill of financial year 2022-23 received after 10th April 2023, may not be considered by Branch Office of the corporation for payment.
23. ARBITRATION CLAUSE:
  1. This contract is subject to the Jurisdiction of Branch office Mahabubnagar at Mahabubnagar, in case of any dispute.
  2. Any dispute arises out of this contract, will be referred to an Arbitrator (not an Employee of the Corporation) whose appointment will be made by the Branch Head, Mahabubnagar and the decision of the arbitrator will be binding on both the parties. The dispute shall be governed by Arbitration and Conciliation Act 1996.
24. I / We the Job contractor undertake to submit "Clearance Certificate" of all the dues payable to P.F. Department in the year end before claiming the security deposit from the Corporation, if required.
25. I / We the Job work contractor shall abide by terms and conditions mentioned above. If any Terms & Conditions violated by the Job work contractor, then the Corporation will have a right to cancel the contract after giving three days' notice and the Corporation will have the right to forfeit the security deposit & EMD lying with the Corporation.
26. The Corporation does not guarantee minimum work to the Contractor.
