#### **TERMS AND CONDITIONS**

- 1. Tenders should be submitted in the prescribed format in form of "Bid-I and Bid-II". The transporters should submit these two bids in separate sealed envelope duly marked as "Bid-I (Technical) and Bid-II (Financial)" and then place the two sealed envelopes into one envelope duly sealed and superscribed as "Tender for transportation of F.P. Bales for the cotton season 2022-23". Bid-I should be submitted along with EMD, cost of tender & all other documents desired as per tender. Bid-II shall contain only financial bid.
- The rate quoted should be on per bale basis including Weighbridge Weighment, Unloading, Rolling & upto stacking in godown, and all other expenses, inclusive of all taxes, excluding loading at factory & GST.
- 3. The contract will be effective till 30-09-2023 from the date of issue of the confirmation letter.
- 4. Once rates are finalized no escalation in the rates will be accepted during the contracted period for any reason and no extra charges will be paid by the Corporation on account of detention of the trucks.
- 5. The party has to enclose EMD of Rs.50000/- for each centre separately by way of D.D/P.O drawn (any nationalized bank/Scheduled bank) in favour of "THE COTTON CORPORATION OF INDIA LIMITED" payable at "Aurangabad" along with the tender. MSE firms are exempted for EMD on production of valid MSE certificates; however security deposit of Rs 50000/- for each center separately has to be deposited in Branch Office by successful bidders before signing of agreement. No interest will be paid on EMD & Security Deposit. EMD & Security Deposit will be refunded after satisfactory completion of work.
  - 6. Tender should be submitted strictly in the prescribed tender form which can be had from Branch Office during working hours on any working day by payment of Rs.112/- (Rupees Hundred and Twelve only inclusive of GST) by way of DD/PO/BANK TRANSFER each set upto 11.00 am on 06/09/2022. Those who are downloading the tender forms from the website shall have to pay Rs.112/- (Rupees Hundred and Twelve only inclusive of GST) by D.D/PO. Infavour of "The Cotton Corporation of India Limited, Aurangabad" or tender fee should be paid by Electronic Fund Transfer/Digital mode of payment such as BHIM, UPI (UPI/BHIM-UPI QR Code) and RTGS/NEFT. Electronic Fund transfer will be valid subject to confirmation of realization. MSE firms are exempted for Tender fees on production of valid MSE certificate.
- 7. Tender should be submitted in sealed covers duly superscribing "Tender for Transportation of Bales for cotton season 2022-23" addressed to Dy. General Manager, CCI, Aurangabad on or before 2.00 pm on **06/09/2022** and the Tenders shall be opened on same day at 2.30 pm before the tenderers who wish to remain present. The Financial bid-II of the tenders who qualified for the technical bid will be opened on **06/09/2022** at 3:30 PM.
- 8. All columns in the tender form should be filled clearly and legibly. Tender form found incomplete in any respect is liable to be rejected.
- 9. Transporters having legal dispute continuing/ pending with the Cotton Corporation of India Limited as well dues payable by the Transporter shall not eligible to participate.
- 10. Adequate vehicles should be placed on day to day basis according to corporation's requirement. Transporter should be able to place extra vehicles also, instantly in case of demand by the Center Incharge.

- 11. The transporter will have to transport the bales within 48 hours from the intimation and in case of failure the corporation will arrange the work through other transporters at its discretion and the difference of rate/ loss/damage/over heads if any sustained will be recovered from the transporter in addition to the forefeiting the EMD. Since the quantam of work is on adhoc basis and the same is uncertain, The Corporation also reserves its right that if the L-1 tenderer fails to perform the work in time bound manner, the same work will be allotted to L-2 transporter if they agrees to work on the rates of L-1.
- 12. The bales should be transported by the transporter within the stipulated time (i.e 48 hours from Pressing of bales / immediately after completion of cooling period in factory) to the mentioned destination place otherwise penalty will be levied as per the decision taken by Competent Authority for the delayed bales lifted and the same will be recovered from the transporter's bill to the extent that the losses to the Corporation are made good / recovered.
- 13. The transporter will ensure proper safety of the goods being transported in good condition in neat and clean vehicle. In case of any incidents tendering to lead to any loss or damage transporter will make it good to the corporation. Whatever may be decided by the competent authority of the corporation.
- 14. The transporter is responsible for any complication because of excess/ short loading.
- 15. The transit loss/theft, if any, observed shall be deducted proportionately from the transportation bills/E.M.D.
- 16. Bales should be loaded lot-wise and no intermixing of lots will be allowed.
- 17. All statutory deductions such as Income Tax, Surcharges etc., will be deducted from the bills at the prevailing rates as per Income Tax Act 1961 under Section 194(C).
- 18. In transit the bales will have to be covered with tarpaulins and proper protection of stock should be taken by the Transporter.
- 19. The vehicle should be clean and the vehicles carrying coal, cement, chemicals etc., which cause damage to Cotton Bales should not be used.
- 20. If any damage caused due to transportation of bales, then the recovery will be made from concerned transporter as determined by the Corporation.
- 21. In case of any accident or eventuality during the transit the same should be informed to BRANCH OFFICE, AURANGABAD/concerned Center Incharge/Godown Incharges immediately, besides completing the formalities of lodging F.I.R. with police, investigation report, arrangement of Fire Brigade report and photographs etc., The transporter will be responsible for submitting copies of F.I.R., fire brigade report etc., wherever necessary. Without preliminary survey truck/ salvage should not be removed.
- 22. The bills accompanied with gate pass,L.R. copy, E-way bill copy & GST delivery challan along with acknowledgement of goods received in good condition from concern godown in charges & other supporting documents duly acknowledged by Centre Incharge should be submitted to Branch Office for settlement of bills. 10% amount of the bill will be deducted towards security deposit along with Income Tax and other taxes if any applicable from time to time. 10% security deposit shall be refunded on satisfactory completion of work during the contracted period. However no interest will be paid on such security deposit.
- 23. The payment will be made through e payment (RTGS/NEFT etc.).

- 24. The transporter should contact Centre Incharge, Godown Incharge and Branch Office on daily basis for ascertaining the requirement of vehicles.
- 25. During the season transporter should transport any bursted/damaged bales from godown to factory and after repressing the repressed bales should transported to godowns as per finalized, per bale basis rate, by the same transporter.
- 26. In case if the damage is caused during transportion, the same shall be re-pressed and transported on account of transporter. The Transporter shall ensure that only fully pressed, covered, neat and clean bales are loaded into the truck.
- 27. Godown location may be included depending on availability and actual engagement of godowns.
- 28. The corporation reserves the right to accept/reject any tender. In case of non acceptance of tender, the tenderer can seek information for the reason of non acceptance from the branch office of the corporation. However the corporation reserves its right for negotiation.
- 29. Transporter must give undertaking that if TDS is not applicable, he is having less than 10 Vehicles along with copy of Pan card.
- 30. During the process of transportation of F.P. bales from CCI center to godown for storage purpose, 1st weighment is done at the Center level / Factory level by the Factory / Center Incharge. At the time of unloding of bales at godown, 2nd weighment of Gross-Tare-Net weight of F.P. bales will have to be done at near-by weightbridge by the transporter and the weightment slip should be compulsorily attached with the bill along with e-way bill, L-R copy etc. Any abnormal difference in 1st weight and 2nd weight, should be immediately brought to the notice of the C/I by the transporter. The weightment cost should be included in the transportation rates at the time of submitting tender.
- 31. Mere submission of the tender form does not entitle any contractor to be engaged by the Corporation. The Corporation is not bound to allocate minimum work to the tenderer.
- 32. GST E-Way Bill, for movement of corporation's stock, will be generated by the transporters as per GST act & provisions. If any liability arises to the corporation due to non-generation /wrong generation of e-way bill, it will be recovered from the transporter.
  - (i) Transporter must give undertaking in the enclosed format, declaring that the transporter have carriage less than 10 along with copy of PAN Card.

# AGREEMENT FOR ENGAGING TRANSPORTATION WORK OF F.P. BALES FOR COTTON SEASON 2022-23 An Agreement made at AURANGABAD this \_\_\_\_\_\_ day of \_\_\_\_\_ (Year) between The Cotton Corporation of India Limited, a company registered under the Companies Act, 1956 having its Registered Office at Kapas Bhavan Plot No. 3A, Sector 10, CBD Belapur, Navi Mumbai-400614. (Herein after for brevity's sake called the "Corporation" which expression shall unless repugnant to the context or meaning thereof include its successors and assigns) OF THE FIRST PART TRANSPORTER (hereinafter AND for brevity's sake called "The transporter" which expression shall unless repugnant to the context or meaning thereof include its successors and assigns) being represented by its owner as well as by representative if any , of the SECOND PART . WHEREAS the transporter, known by the name of -----is owned/ is leased/ is licensed by----- (owner's name) to----- (Lessee/Licensee's name). AND WHEREAS the transporter has offered to do the work of Bales transportation for the Corporation during the cotton season 2022-23 on contract. AND WHEREAS the Corporation has accepted the offer on the terms and conditions contained herein.

The transporter agrees to transport the F.P. Bales from Pressing factories to Godowns engaged by the Corporation at the following rates.

- 1. The above rates are including Weighbridge Weighment, Unloading, Rolling & upto stacking and all other expenses, inclusive of all taxes, excluding loading at factory & GST.
- 2. No escalation in rates during the contracted period on any ground.
- 3. The transporter will have to place adequate vehicles on day —to- day basis according to requirement. Transporter should be able to place extra vehicles also, instantly in case of demand by the Center Incharge.
- 4. Bales should be loaded lot-wise and no intermixing of lots will be allowed.
- 5. Transporter will have to transport Bales immediately on Centre Incharge Communication/ Pressing Factory. In case of failure, the corporation will arrange the work through other transporters at its discretion and the loss/ damage/over heads if any will be recovered from the transporter besides forfeiture of EMD.
- 6. The transporter will have to transport the bales within 48 hours from the intimation and in case of failure the corporation will arrange the work through other transporters at its discretion and the difference of rate/ loss/damage/over heads if any sustained will be recovered from the transporter in addition to the forefeiting the EMD. The Corporation also reserves its right that if the L-1 tenderer fails to perform the work in time bound manner, the same work will be allotted to L-2 transporter if they agrees to work on the rates of L-1.
- 7. The bales should be transported by the transporter within the stipulated time (i.e 48 hours from Pressing of bales / immediately after completion of cooling period in factory) to the mentioned destination place otherwise penalty will be levied as per the decision taken by Competent Authority for the delayed bales lifted and the same will be recovered from the transporter's bill to the extent that the losses to the Corporation are made good / recovered.

- 8. While transporting the F.P. bales proper care should be taken for safety and no damage should occur during transit. In case of any incidents tendering to lead to any loss or damage transporter will make it good to the corporation. Whatever may be decided by the competent authority of the corporation.
- 9. The transporter is responsible for any complication because of excess/ short loading.
- 10. The transit loss/theft, if any, observed shall be deducted proportionately from the transportation bills/E.M.D.
- 11. In Case if the damage is caused during transportation, the same shall be re-pressed and transported on account of transporter. The transporter shall ensure that only fully pressed, covered, neat and clean bales are loaded into the truck.
- 12. In transit the proper protection of stock including full coverage by tarpaulins should be taken by transporter.
- 13. The vehicle should be clean and the vehicles carrying coal, cement, chemicals etc. which cause damage to bales should not be used.
- 14. If any damage caused due to transportation of bales, then the recovery will be made from concerned transporter as determined by the Corporation.
- 15. In case of any accident or eventuality during the transit the same should be informed to BRANCH OFFICE, AURANGABAD/ concerned center in charge/Godown Incharge immediately, besides completing the formalities of lodging F.I.R. with police, investigation report, arrangement of Fire Brigade report and photographs etc., The transporter will be responsible for submitting copies of F.I.R. fire brigade report etc., wherever necessary. Without preliminary survey truck/ salvage should not be removed.
- 16. The transporter will have to contact Centre Incharges on day to day basis for requirement of vehicles.
- 17. The bills accompanied with gate pass, L.R. copy, E-way bill copy & GST delivery challan along with acknowledgement of goods received in good condition from concern godown in charges/center in charge other supporting documents duly acknowledged by Centre In charge should be submitted to Branch Office for settlement of bills. 10% amount of the bill will be deducted towards security deposit along with Income Tax and other taxes if any applicable from time to time. 10% security deposit shall be refunded on satisfactory completion of work during the contracted period. No interest will be paid on such security deposit.
- 18. The payment will be made through e payment (RTGS/NEFT etc.)
- 19. This agreement does not bind the Corporation to offer the whole or any part of its transportation work to the transporter. The Corporation may offer the work of transportation to the transporter at its own convenience on the basis of circumstances prevailing and the transporter shall have no right to claim work from the corporation.

- 20. During the season transporter should transport any brusted/damaged bales from godowns to factory and after repressing the repressed bales should transported to godowns as per finalized, per bale basis rate, by the same transporter. In case if the damage is caused during transportion, the same shall be re-pressed and transported on account of transporter.
- 21. Transport shall ensure that only fully pressed, covered, neat and clean bales are loaded into the truck.
- 22. The Corporation reserves the right to withdraw its transportation work or terminate this agreement without assigning any reason.
- 23. The Transporter is a company/ partnership/ Proprietary/ Joint Family concern copies of documents evidencing this are annexed hereto.
- 24. GST E-Way Bill, for movement of corporation's stock, will be generated by the transporters as per GST act & provisions. If any liability arises to the corporation due to non-generation /wrong generation of e-way bill, it will be recovered from the transporter.
- 25. The transporter will ensure proper safety of the goods being transported in good condition in neat and clean vehicle. In case of any incidents rendering to lead to any loss or damage transporter will make it good to the corporation. Whatever may be decided by the competent authority of the corporation.
- 26. During the process of transportation of F.P. bales from CCI center to godown for storage purpose, 1st weighment is done at the Center level / Factory level by the Factory / Center Incharge. At the time of unloding of bales at godown, 2nd weighment of Gross-Tare-Net weight of F.P. bales will have to be done at near-by weightbridge by the transporter and the weightment slip should be compulsorily attached with the bill along with e-way bill, L-R copy etc. Any abnormal difference in 1st weight and 2nd weight, should be immediately brought to the notice of the C/I by the transporter.

This agreement is being executed by Shri ------ on behalf of the transporter on the strength of a power of attorney executed a resolution passed on -----. A copy of the power of attorney/resolution is also annexed to this agreement.

The transportation agreement shall be valid for cotton season 2022-23 i.e. up to 30-09-2023 and there shall be no escalation/Revision of rate during the season.

In case of any dispute or difference arising out of or in relation to this agreement, the same will be referred to arbitration of an Arbitrator (other than an employee of the Corporation) to be appointed by the Branch Head of the Corporation and whose decision shall be final and binding upon the parties hereto. The arbitration will be governed by the provisions of the Arbitration & Conciliation Act, 1996.

This Agreement shall be subject to Jurisdiction of Courts of AURANGABAD only.
