#### TERMS AND CONDITIONS

 Tenders should be submitted in the prescribed format in form of "Bid-I and Bid-II". The transporters should submit these two bids in separate sealed envelope duly marked as "Bid-I (Technical) and Bid-II (Financial)" and then place the two sealed envelopes into one envelope duly sealed and superscribed as "Tender for transportation of F.P.Bales for the cotton season 2022-23". Bid–I should be submitted along with EMD, cost of tender & all other documents desired as per tender. Bid–II shall contain only financial bid.

#### 2. <u>The rate quoted should be on per bale basis including unloading charges, rolling and up</u> to stacking and all other expenses, inclusive of all taxes, excluding loading at factory & <u>GST</u>.

- 3. The contract will be effective till 30-9-2023 from the date of issue of the confirmation letter.
- 4. Once rates are finalized no escalation in the rates will be accepted during the contracted period for any reason and no extra charges will be paid by the Corporation on account of detention of the trucks.
- 5. The party has to enclose EMD of Rs.50000/-for each centre separately by way of D.D/P.O drawn(any nationalized bank/Scheduled bank) in favour of "THE COTTON CORPORATION OF INDIA LIMITED" payable at "<u>Rajkot</u>" along with the tender. <u>MSE firms are exempted for EMD on production of valid MSE certificates; however security deposit of Rs 50000/-for each center separately has to be deposit in branch office by successful bidders before signing of agreement. No interest will be paid on EMD & Security Deposit. EMD & Security Deposit will be refunded after satisfactory completeion of work.</u>
- 6. Tenders should be submitted strictly in the prescribed tender form which can be had from Branch Office during working hours on any working day by payment of Rs.112/- (Rupees Hundred and Twelve only inclusive of GST) each set upto <u>01.00pm.on</u> <u>26.08.2022</u>. Those who are downloading the tender forms from the website shall have to pay Rs.112/-(Rupees Hundred and Twelve only inclusive of GST) by D.D/PO. infavour of " The Cotton Corporation of India Limited, <u>Rajkot</u> " and submit the same to branch office along with tender form. MSE firms are exempted from tender fees on production of valid MSE certificate.
- 7. Tenders should be submitted in sealed covers duly superscribing<u>" Tender for Transportation of Bales for 2022-23"</u> addressed to Dy. General Manager, CCI, <u>Rajkot</u> on or before 01.00. on 26.08.2022 and the Tenders shall be opened on same day at Rajkot before the tenderers who wish to remain present.
- 8. All columns in the tender form should be filled clearly and legibly. Tender form found incomplete in any respect is liable to be rejected.
- 9. Transporters having legal dispute continuing/ pending with the Cotton Corporation of India Limited as well dues payable by the Transporter is not eligible to participate.
- 10. Adequate vehicles should be placed on day to day basis according to corporation's requirement. Transporter should be able to place extra vehicles also, instantly in case of demand.

- 11. The transporter will have to transport the bales within 24 hours from the intimation and in case of failure the corporation will arrange the work through other transporters at its discretion and the differenceof rate/ loss/damage/over heads if any sustained will be recovered from the transporter in addition to the forefeiting the EMD.
- 12. The transporter will ensure proper safety of the goods being transported in good condition in neat and clean vehicle. In case of any incidents to or tendering to lead to any loss or damage transporter will make it good to the corporation. As decided by the Corporation.
- 13. The transporter is responsible for any complication because of excess/ short loading.
- 14. The transit loss if any observed shall be deducted proportionately.
- 15. Bales should be loaded lot-wise and no intermixing of lots will be allowed.
- 16. 100 Bales should be loaded lot-wise and no intermixing of lots will be allowed. If 150 bales are loaded by the transporter , then proper partition will have to be done by laying plastic. Before loading the bales by the transporter , proper plastic shall be plastered on the floor of the truck , otherwise in case the bales deteriorate due to any reason, the transporter will held full responsibility .
- 17. All statutory deductions such as Income Tax, Surcharges etc., will be deducted from the bills at the prevailing rates as per Income Tax Act. 1961 under section 194(C).
- 18. In transit the bales will have to be covered with tarpaulins and proper protection of stock should be taken by the Transporter.
- 19. The vehicle should be clean and the vehicles carrying coal, cement, chemicals etc., which cause damage to Cotton should not be used.
- 20. If any damage caused due to transportation of bales, then the recovery will be made from concerned transporter as determined by the Corporation.
- 21. In case of any accident or eventuality during the transit the same should be informed to BRANCH OFFICE ,**RAJKOT**./concerned center incharge immediately, besides completing the formalities of lodging F.I.R. with police, investigation report, arrangement of Fire Brigade report and photographs etc., The transporter will be responsible for submitting copies of F.I.R. fire brigade report etc., wherever necessary. Without preliminary survey truck/salvage should not be removed.
- 22. <u>The bills accompanied with gate pass,L.R. copy along with acknowledgement of goods</u> received in good condition from concern godown incharges, duly acknowledged by <u>Centre Incharge should be submitted to Branch Office for settlement of bills</u>. 10% amount of the bill will be deducted towards security deposit along with Income Tax and other taxes if any applicable from time to time. 10% security deposit shall be refunded on satisfactory completion of work during the contracted period. However no interest will be paid on such security deposit.
- 23. If bills received without supporting documents as mentioned above , payments will not be released until the complete documents submitted at Branch Office by the concerned transporter.
- 24. The payment will be made through e payment (RTGS/NEFT etc.).
- 25. The transporter should contact Centre Incharge, Godown Incharge and Branch Office on daily basis for ascertaining the requirement of vehicles.

- 26. The corporation reserves the rights to accept/ partly accept/ reject/ any/ all tenders or negotiate in full or in part without assigning any reason whatsoever.
- 27. During the season transporter should transport any bursted/damaged bales from godowns to factory and after repressing the repressed bales should transported to godowns as per finalized, per bale basis rate, by the same transporter.
- 28. In case if the damage is caused during transportation, the same shall be re-pressed and transported on account of transporter. The Transporter shall ensure that only fully pressed, covered, neat and clean bales are loaded into the truck.
- 29. GST E-Way Bill, for movement of Corporation's stock, will be generated by the transporters as per GST act & provisions. If any liability arises to the corporation due to non-generated / wrong generation of e-way bill, it will be recovered from the transporter.
- 30. Godown locations may be included depending on availability and actual engagement of godowns.
- 31. The corporation reserves the right to accept/reject any tender. In case of non acceptance of tender, the tenderer can seek information for the reason of non acceptance from the branch office of the corporation.
- 32. Mere submission of the tender form does not entitle any contractor to be engaged by the Corporation. The Corporation is not bound to allocate minimum work to the tenderer.
- 33. Transporter must give undertaking that if TDS is not applicable, he is having less than <u>10</u> vehicles along with copy of PAN card.

#### AGREEMENT FOR ENGAGING TRANSPORTATION WORK OF F.P. BALES

(hereinafter for brevity's sake called "The transporter" which expression shall unless repugnant to the context or meaning thereof include its successors and assigns) being represented by its owner as well as by representative if any, of the SECOND PART.

- 1. The above rates are including unloading charges, and all other expenses, inclusive of all taxes, excluding loading at factory & GST.
- 2. No escalation in rates during the contracted period on any ground.
- 3. The transporter will have to place adequate vehicles on day –to- day basis according to requirement.
- 4. Transporter will have to transport Bales immediately on Centre Incharge Communication/ Pressing Factory. In case of failure, the corporation will arrange the work through other transporters at its discretion and the loss/ damage/over heads if any will be recovered from the transporter besides forfeiture of EMD.
- 5. While transporting the F.P. bales proper care should be taken for safety and no damage should occur during transit.
- 6. The transporter is responsible for any complication because of excess/ short loading.
- 7. The transit loss if any observed shall be deducted from the transporters payment proportionately.
- 8. In Case if the damage is caused during transportation, the same shall be re-pressed and transported on account of transporter. The transporter shall ensure that only fully pressed, covered, neat and clean bales are loaded into the truck.
- In transit the proper protection of stock including full coverage by tarpaulins should be taken by transporter.
- 10. Bales should be loaded lot-wise and no intermixing of lots will be allowed.
- 11. The vehicle should be clean and the vehicles carrying coal, cement, chemicals etc. which cause damage to bales should not be used.
- 12. If any damage caused due to transportation of bales, then the recovery will be made from concerned transporter as determined by the Corporation.

- 13. In case of any accident or eventuality during the transit the same should be informed to BRANCH OFFICE, <u>Raikot</u>/concerned center in charge immediately, besides completing the formalities of lodging F.I.R. with police, investigation report, arrangement of Fire Brigade report and photographs etc., The transporter will be responsible for submitting copies of F.I.R. fire brigade report etc., wherever necessary. Without preliminary survey truck/ salvage should not be removed.
- 14. The transporter will have to contact Centre In charges on day to day basis for requirement of vehicles.
- 15. The bills accompanied with gate pass, L.R. copy along with acknowledgement of goods received in good condition from concern godown in charges, duly acknowledged by Centre In charge should be submitted to Branch Office for settlement of bills. 10% amount of the bill will be deducted towards security deposit along with Income Tax and other taxes if any applicable from time to time. 10% security deposit shall be refunded on satisfactory completion of work during the contracted period.
- 16. The payment will be made through e payment (RTGS/NEFT etc.).
- 17. This agreement does not bind the Corporation to offer the whole or any part of its transportation work to the transporter. The Corporation May offer the work of transportation to the transporter at its own convenience on the basis of circumstances prevailing and the transporter shall have no right to claim work from the corporation.
- 18. During the season transporter should transport any brusted/damaged bales from godowns to factory and after repressing the repressed bales should transported to godowns as per finalized, per bale basis rate, by the same transporter.
- 19. The Corporation reserves the right to withdraw its transportation work or terminate this agreement without assigning any reason.
- 20. The Transporter is a company/ partnership/ Proprietary/ Joint Family concern copies of documents evidencing this are annexed hereto.

This agreement is being executed by Shri ------ on behalf of the transporter on the strength of a power of attorney executed a resolution passed on -----------. A copy of the power of attorney/resolution is also annexed to this agreement.

The transportation agreement shall be valid for cotton season 2022-23 i.e. up to 30-09-2023 and there shall be no escalation/Revision of rate during the season.

In case of any dispute or difference arising out of or in relation to this agreement, the same will be referred to arbitration of an Arbitrator (other than an employee of the Corporation) to be appointed by the Branch Manager of the Corporation and whose decision shall be final and binding upon the parties hereto. The arbitration will be governed by the provisions of the Arbitration & Conciliation Act, 1996.

This Agreement shall be subject to Jurisdiction of Courts of Rajkot only.
